

March 23rd: The House successfully passed the "skinny budget" deal approved by the Senate last week, as well as the emergency unemployment bill. **The House and Senate have both adjourned until April 13th, or until such a time that the president and speaker determine.**



Governor Ducey announcing the state will be reopening closed hospitals, utilizing anesthesia equipment for the respirators, and issuing an executive order for labs to report how many tests are being given.

PPE & Supply Requests:

- There is extremely limited PPE available for order. It is very important that you realize that submission of a resource request does not guarantee your order will be filled. Orders will be prioritized based on critical healthcare and current supplies.
- **Before submitting a PPE request you must prove that you have taken the following steps:**
 - Follow CDC's guidance on optimizing PPE Supplies.
 - Reach out to multiple vendors. If vendors cannot supply your order, keep the documentation.
 - Reach out to other partners in the area. Many jurisdictions are already sharing with each other.
 - Reach out to partners outside of the area. Partners in other states might have extra supplies to help bridge gaps in back orders.

TECHNICIANS & PTCB

The Board of Pharmacy will extend the tech trainees with licenses through May 31, 2020, for those tech trainees that expire on March 31, 2020 or April 30, 2020

For those who have applied and/or have scheduled to test:

- Pearson VUE has suspended test delivery at its company-owned US and Canada-based testing centers until at least April 16 or whenever conditions are safe to reopen.

For recertification candidates:

- We have extended recertification deadlines for 60 days for CPhTs and Certified Compounded Sterile Preparation Technicians (CSPTs) who have March 31, April 30, and May 31 expiration dates to allow them extra time for completing CE and submitting applications.

DEA

- Drug Enforcement Administration (DEA) guidance for health care practitioners, pharmacists, and patients with regard to early refills on prescriptions for controlled substances. [CLICK HERE](#)
- **CII:** Pursuant to 21 CFR 1306.12(b) “an individual practitioner may issue multiple prescriptions authorizing the patient to receive a total of up to a 90-day supply of a schedule II controlled substance, subject to specific conditions are met. These conditions include, among other things, that the practitioner must sign and date the multiple prescriptions as of the date issued, (21 CFR 1306.05(a)); and, write on each separate prescription the earliest date on which the prescription can be filled (21 CFR 1306.12(b)(ii)). A pharmacy filling such prescription has no authority to change this date, or dispense the controlled substance to the patient prior to that date. **This does not prohibit the practitioner from issuing one prescription for a 90-day supply if allowed by state law and regulation that otherwise comport with 21 CFR 1306.04(a).**
- **CIII-CV:** Which can be refilled under the CSA, some states have issued orders allowing pharmacies to dispense early refills of prescriptions. Subject to the provisions of 21 CFR 1306.06, requiring a pharmacy only to dispense controlled substances in the usual course of professional pharmacy practice, and if the prescription meets the requirements of 21 CFR 1306.04(a), **this practice may be permitted if the early dispensing is allowed by state law and regulation.**



SIGNATURE LOGS & AUDITS

CVS Caremark will be temporarily allowing pharmacies to document the word "COVID" on its signature log with delivery date and delivery time for retail pharmacy patients that choose not to directly sign. If the pharmacy is delivering the Covered Item directly to the patient's home, document by writing "COVID Delivery" when capturing direct signature is not possible.

ESI: Temporary concession to signature log requirement. Effective March 18 through April 30, 2020, if a member's signature is not available due to COVID-19, the pharmacy will be required to make a notation on the hard copy prescription or an electronic annotation tied to the prescription fill stating the reason for unavailability of signature. This concession does not apply to prescriptions required by law to have a signature. For delivered prescriptions, documentation must contain member name, prescription number and date of service or delivery.

ESI suspended all field and desk audits as of 3-23-20

CMS: We are making clear that HHS does not require and will not audit for patient signatures as proof of delivery for any medications, including for controlled substances. Part D sponsors should work with pharmacy benefit managers and other entities to continue to utilize tools at their disposal to make sure beneficiaries are receiving controlled substances appropriately.
